The members of the Buncombe County TDA Board have a fiduciary responsibility to ensure that the tax dollars are spent in accordance with the specific legislation governing their use.

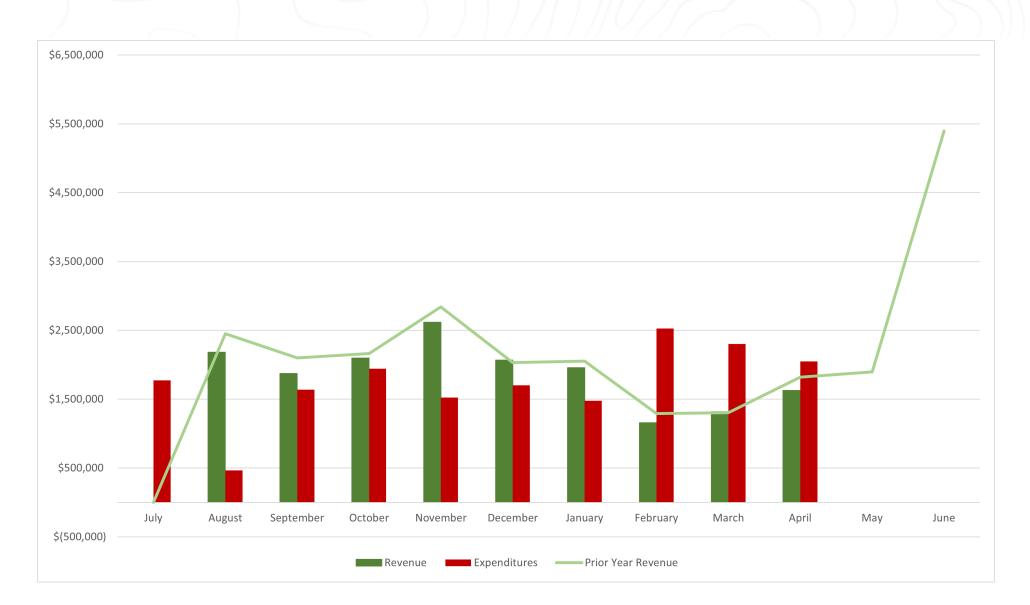

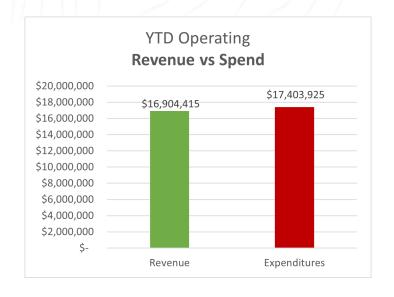

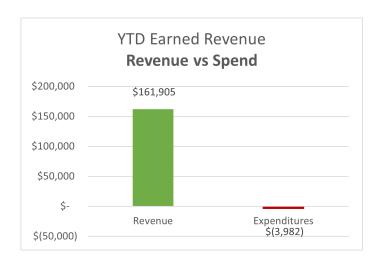


OPERATING AND EARNED REVENUE FUNDS

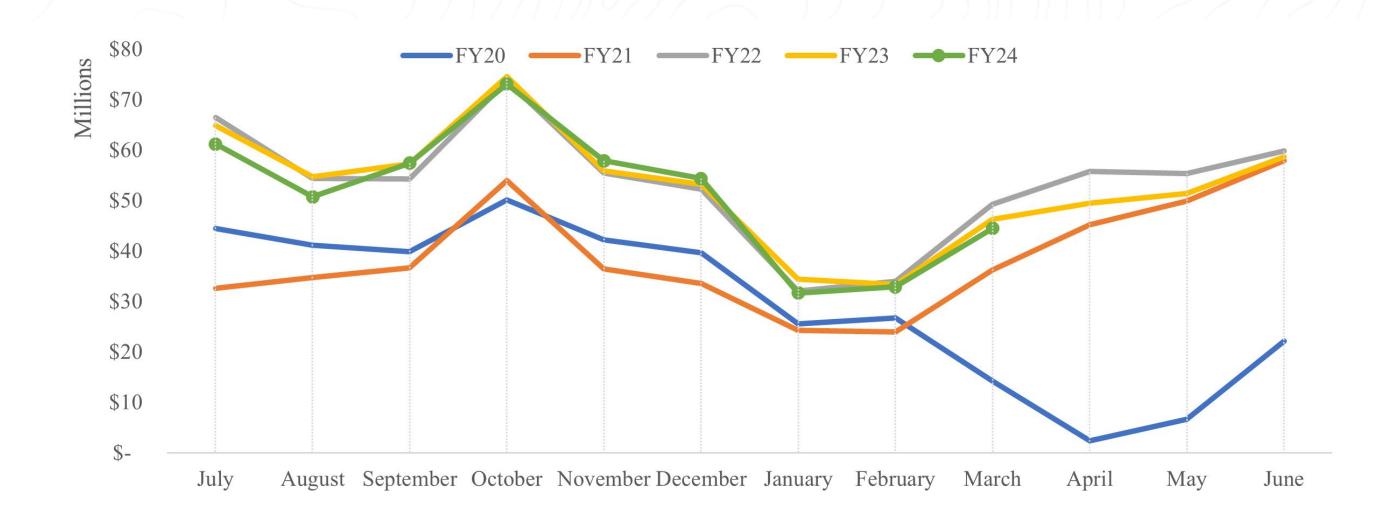

Shown by Month of Sales, Year-to-Date (5 years), April 2024

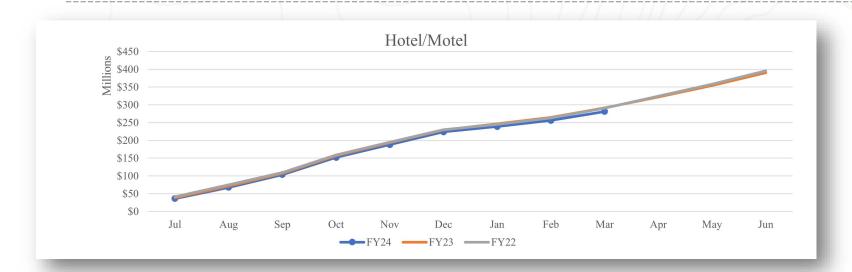

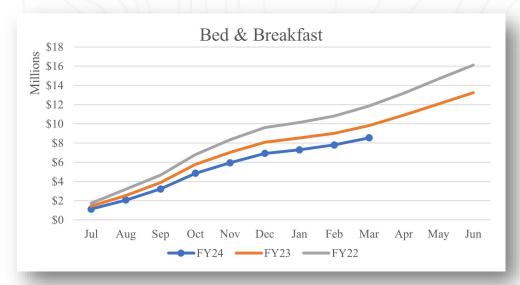

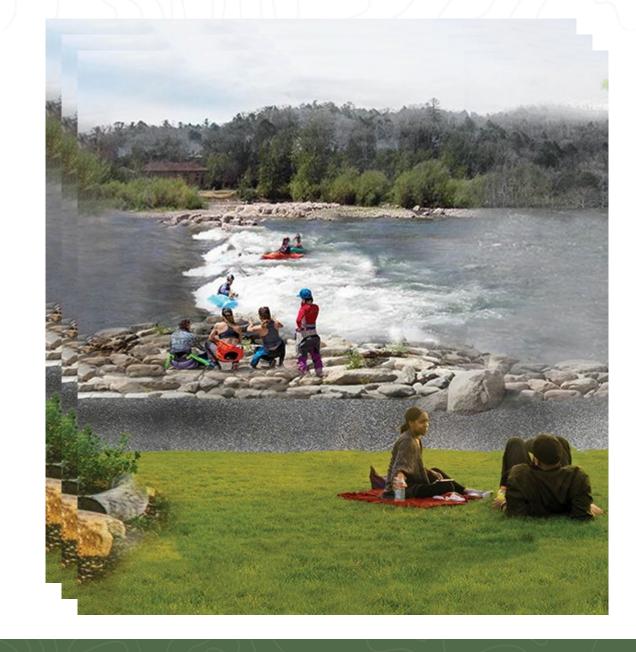


WOODFIN GREENWAY & BLUEWAY (WGB) UPDATE

Third Contract Amendment Request

On May 17, Buncombe County and the Town of Woodfin requested an amendment to the Woodfin Greenway & Blueway contract:

- **Disbursements:** Add the Town of Woodfin as a party to the TPDF contract so that disbursements can be made directly to the Town for the remaining components of the project the Town is responsible for administering, specifically Phase II (Whitewater Wave), and Phase III (Riverside Park)
- **Disbursement Allocation:** Adjust the disbursement allocation as outlined below, increasing the amount to be disbursed for Phase II and decreasing the amount to be disbursed to Phase III. The total award amount will be unchanged.
 - Phase II Disbursement: up to \$2,565,497 (previously \$1,797,387; increase of \$768,110)
 - Phase III Disbursement: up to \$4,064,503 (previously \$4,832,613; decrease of \$768,110)
- **Disbursement Schedule:** Increase the number of disbursements for Phase II and III to a total of 7 disbursements, increasing the number of disbursements for the overall grant to 9 disbursements.

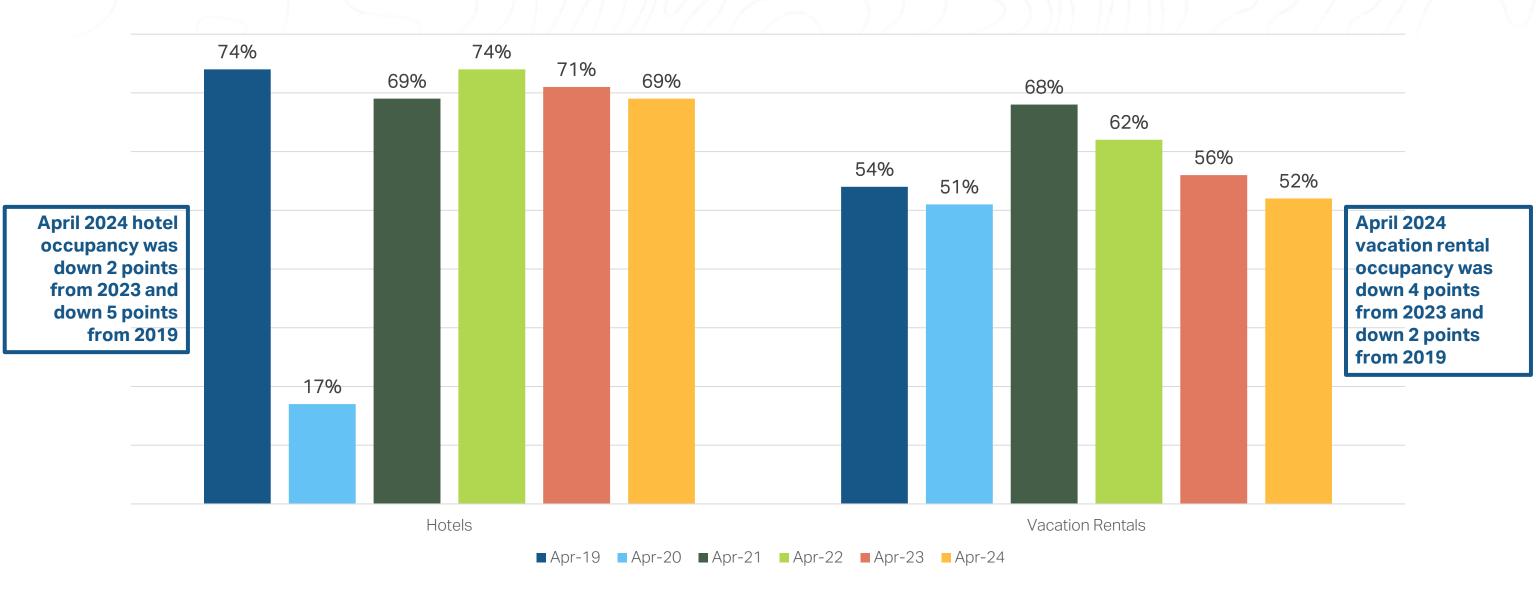

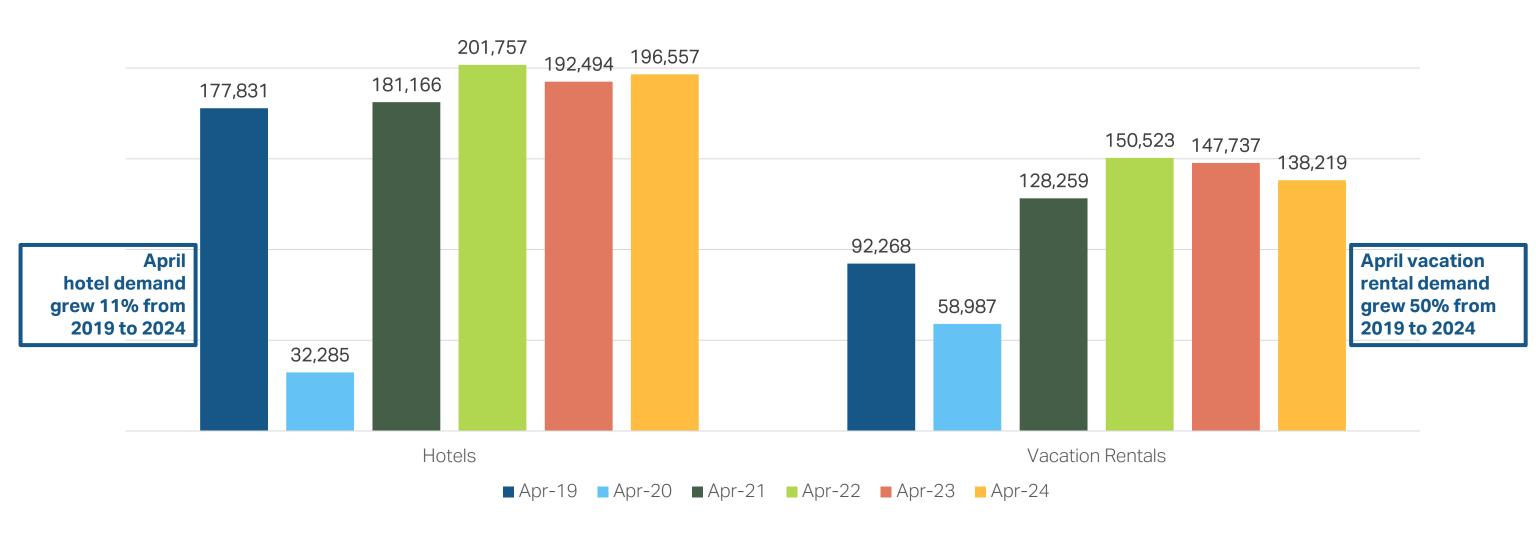


APRIL LODGING OCCUPANCY





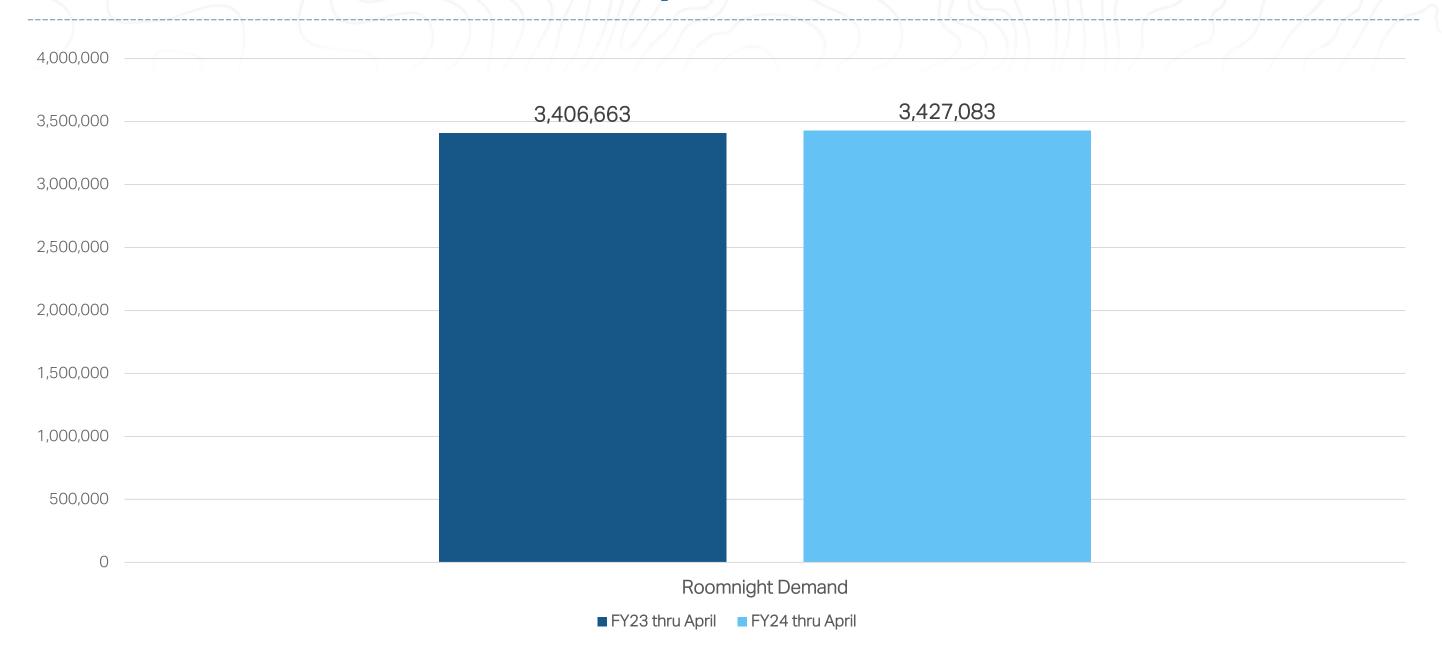
APRIL LODGING DEMAND

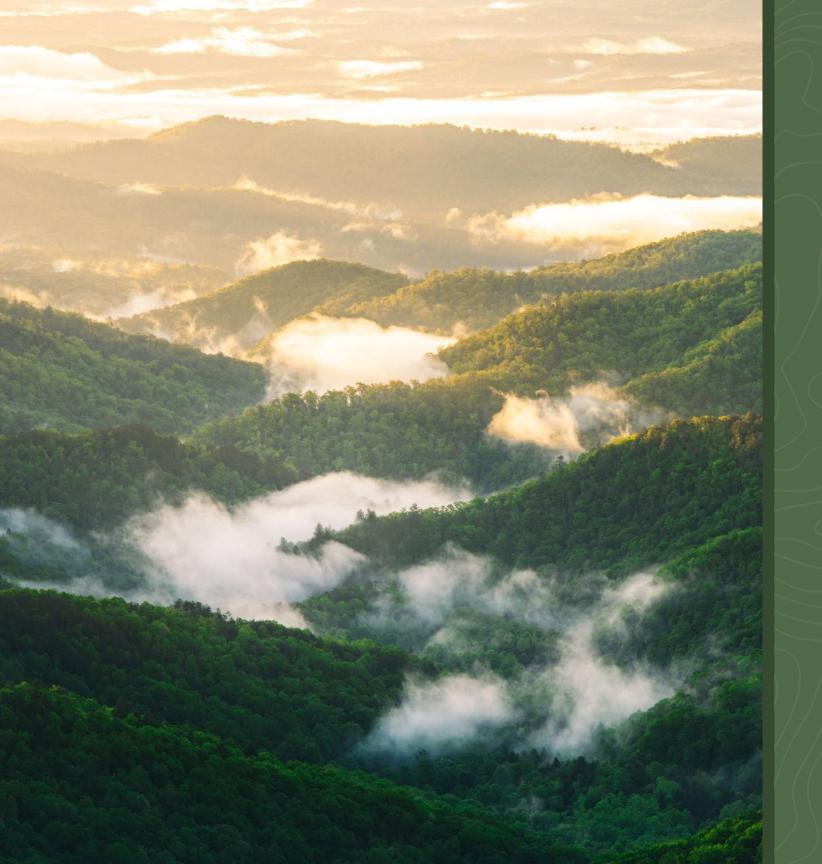

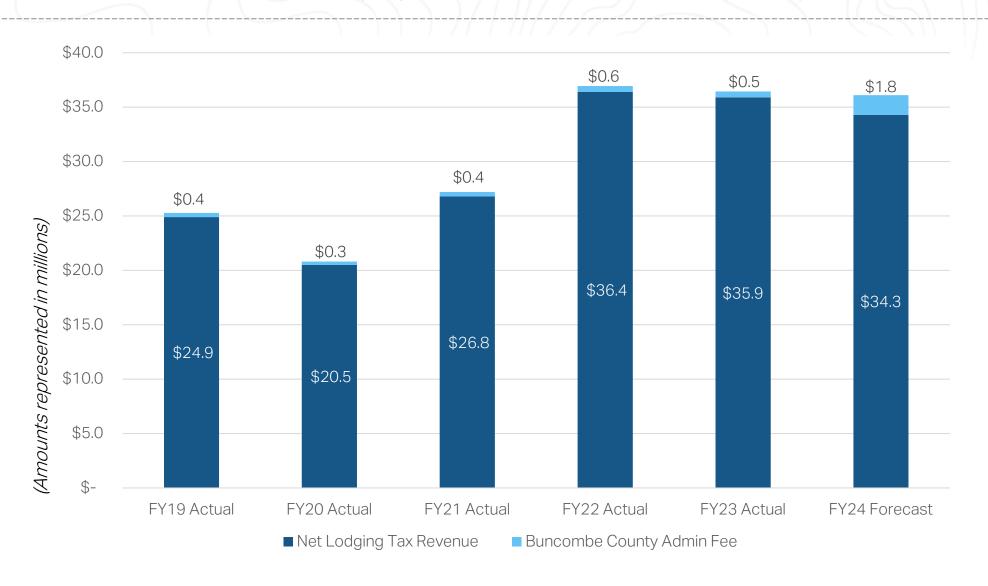

Lodging tax revenue in Buncombe County, FY19-FY24

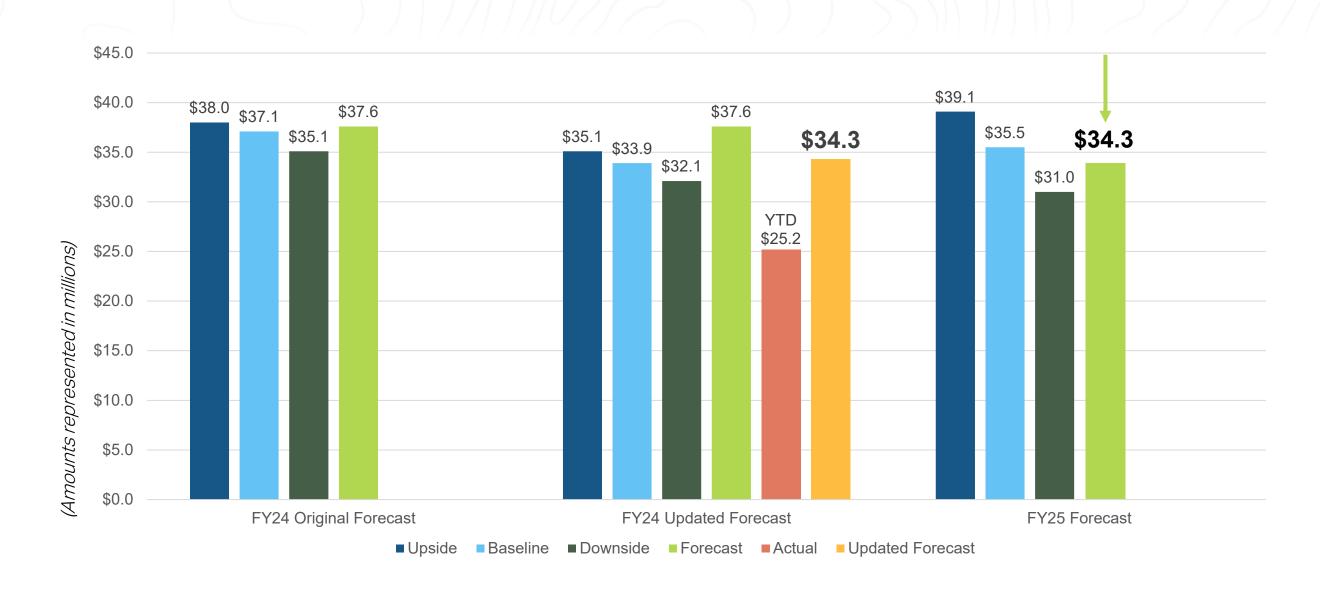


We are projecting net lodging tax revenue for FY24 to go down 5% as compared to FY23, considering the increase in the County admin fee.



FY25 NET LODGING TAX FORECAST

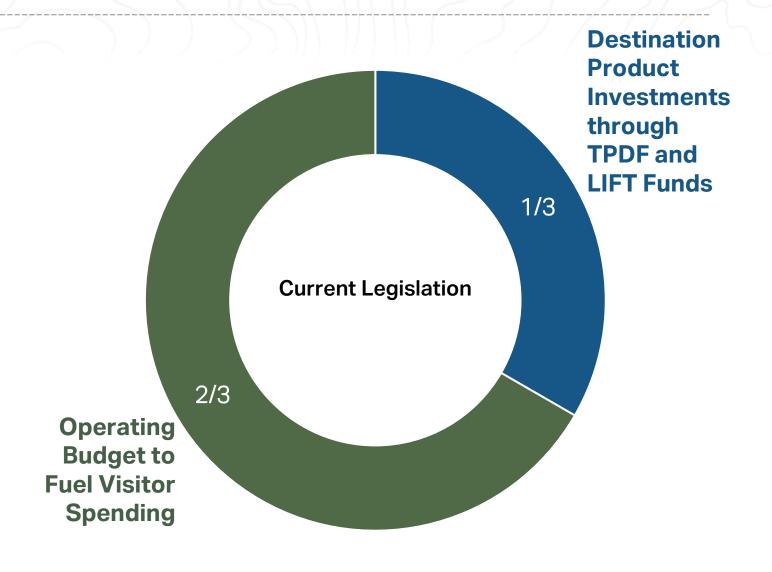
BCTDA forecasting flat revenue growth for the upcoming fiscal year



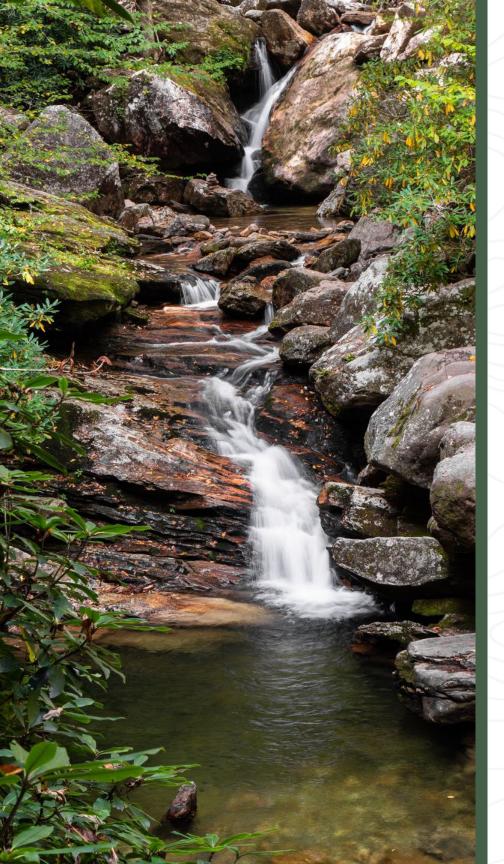


IMPACTS OF LEGISLATIVE CHANGES TAKING SHAPE

- Current legislation now directs additional funds toward community capital investments, and less to marketing and promotion
- Shining a spotlight on Asheville and Buncombe County is still important; strategic investments are critical as the percentage of funds directed toward marketing, advertising, sales, and promotion is reduced
- As sales tax revenues that fuel County and City government budgets slow, the finance committee recommends the use of undesignated contingency to backfill sales and marketing investments to support and maintain local business revenues from visiting customers

BUDGET CONSIDERATIONS

- As a reminder, we're forecasting flat revenue growth in the upcoming fiscal year, in line with our current year revenue forecast
- Gross lodging tax forecast of \$36.1M for FY25, which represents a net revenue forecast for BCTDA of \$34.3M
 - Previously approved by the BCTDA in our March board meeting based on revenue projections provided by Tourism Economics
- Takes into consideration legislation around the administrative support contract between BCTDA and Buncombe County, permitting Buncombe County to charge up to a 5% administrative fee. For FY25, we anticipate the administrative fee will be 5% of gross lodging taxes, or \$1.8M

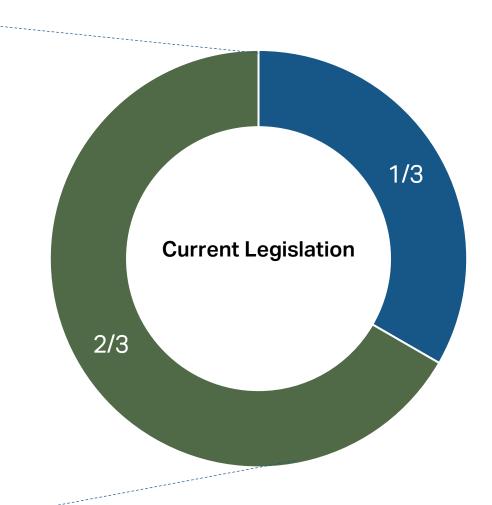


DEFINITION OF TWO-THIRDS BUDGET

Per state legislation

Two-thirds of the funds shall be used only:

- to further the development of travel, tourism, meetings and events in the county through marketing, advertising, sales, and promotion and
- for the administrative expenses of the Authority, not to exceed twenty percent (20%) of the net proceeds for the applicable fiscal year of the Authority. For purposes of this provision, administrative expenses shall include expenses of the Authority for salaries, benefits, operations, and facilities.

FINANCIAL MANAGEMENT POLICY

Designated contingency

- Designated contingency should equal 6 months of annual operating costs (50% expense budget), in alignment with best practices for emergency, crisis management and recovery.
- Use of designated contingency must be approved by the BCTDA board. Requests should include an analysis, determine the use of funds and plans for replenishment.
- The organization's goal is to replenish the funds used within twelve months to restore the designated contingency to the target minimum amount. If the use of contingency will take longer than 12 months to replenish, the request should have an additional layer of scrutiny prior to approval.

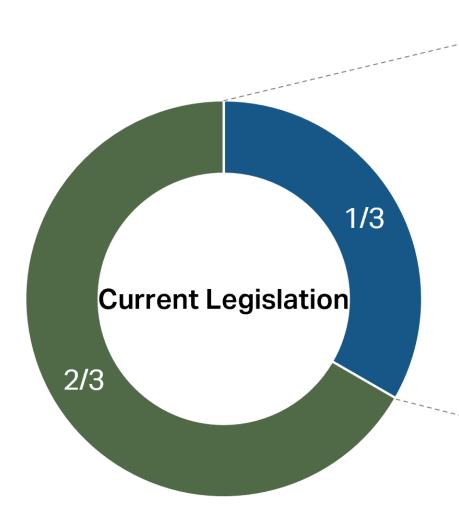

Tourism Product Development Fund (TPDF)

Provide financial investment for major tourism capital projects in order to increase patronage of lodging facilities in, and further economic development in Buncombe County.

Legacy Investment From Tourism Fund (LIFT)

Provide financial investment for tourism-related capital projects in order to increase patronage of lodging facilities, meeting facilities, or convention facilities in Buncombe County by attracting tourists, business travelers, or both, and benefit the community at large in Buncombe County.

FY25 BUDGET RECAP

- As a reminder, we're forecasting flat revenue growth in the upcoming fiscal year, in line with our current year revenue forecast
- Gross lodging tax forecast of \$36.1M for FY25, which represents a net revenue forecast for BCTDA of \$34.3M
 - Previously approved by the BCTDA board based on revenue projections provided by Tourism Economics
- Takes into consideration legislation which dictates the administrative support contract between BCTDA and Buncombe County, representing a 5% administrative fee. For FY25, we anticipate the administrative fee will be \$1.8M
- Recommendation to allocate \$4.3M from fund balance to FY25 operating budget
- We anticipate \$15.3 million to be available for destination product investment through FY25 TPDF and LIFT Fund cycles, compared to \$13.8 million for destination media investment. For the last three years, BCTDA has committed more lodging tax revenue to community capital projects than paid media.
